

KEY INFORMATION ON COSTA RICAN WOMEN IN BUSINESS

- Female labor participation rate (% of female population ages 15-64): 68.92%
- Female-to-male ratio for entrepreneurial activity: 0.28
- Overall, the Costa Rican labor force is 39% female
- On average, Costa Rican women earn an income 45% lower than that of their male counterparts.

WOMEN, BUSINESS AND THE LAW: KEY INDICATOR SCORES

Scores are determined by criteria defined by the World Bank regarding whether a country's legal framework prevents women from accessing certain rights, opportunities or protections. A perfect score is 100, indicating that women are not legally discriminated against and have the same rights and opportunities as men.
